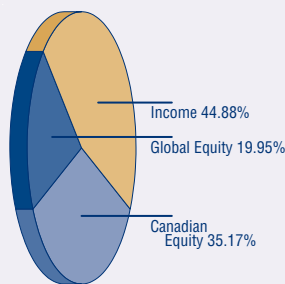

Commentary

The Fund seeks to generate superior long-term growth by favouring a balance between equity securities and fixed-income securities, by diversifying its investments and by integrating several managers. It is composed of fund units offered by Industrial Alliance, which consist of two bond funds, three Canadian equity funds and three global equity funds. The Fund has a fixed asset allocation of 45% in bonds, 35% in Canadian equities and 20% in global equities.

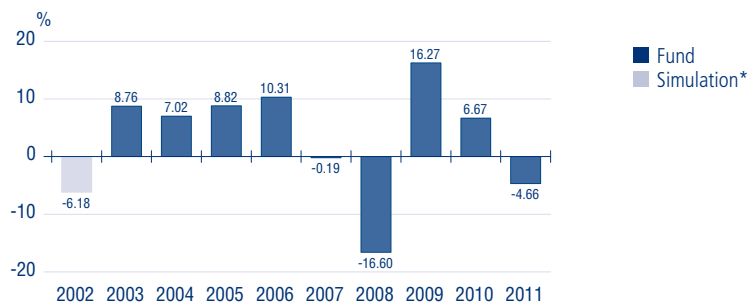

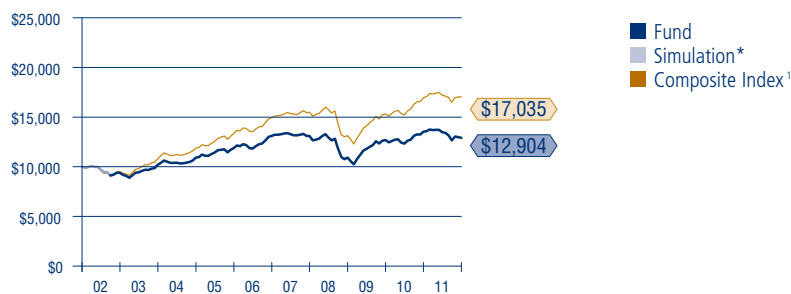
Year By Year Returns
